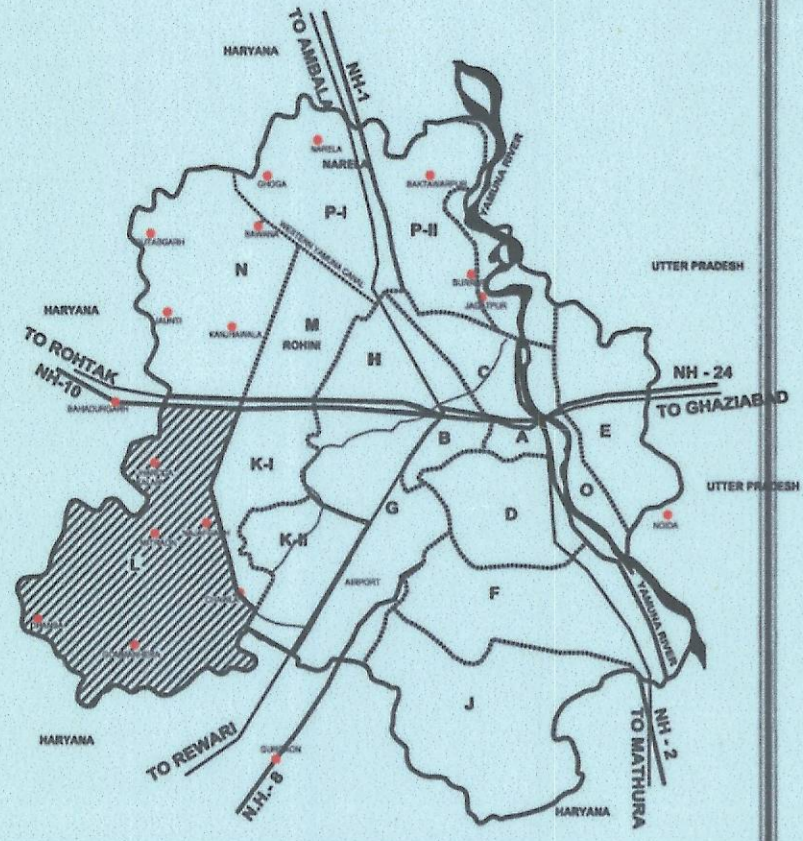

 4. Residential plots under twenty point programme to be processed as per Govt. Policy
