Nomination forms shall be presented in person or sent by registered post with acknowledgement due, by the candidate himself or by his proposer or seconder to the undersigned Returning Officer so as to reach him before the date and hours specified in the agenda notice together with the election fee of INR. 2,100/- and security deposit of INR. 10,000/- in cash or through bank draft or by online remittance (along with proof) in the society's account. The security deposit of candidate, who will lose the election shall be forfeited. It is the responsibility of candidate/proposers/seconder to ensure that dully filled in nomination form are received by the Returning Officer within the prescribed date and time at the said venue. Nomination Forms received after the due date and time at venue will not be accepted/ considered.

## DISQUALIFICATION FROM VOTING OR RIGHT TO CONTEST THE ELECTION

Defaulting members shall be disqualified to contest/ vote for election as per provision of the registered Rules & Regulation of the Society.

However, in case, they make payment of their amount in default before the date of filing of nominations in the society and produce the proof thereof before the Returning Officer, they will not be treated as defaulters and shall be allowed to contest the election or cast their vote.

The proposer and or seconder shall not be defaulter.

The interest members can obtain the list of Voters with the list of Defaulter Members from the President / General Secretary of the Society.

Election shall be held electronically (e-voting).

# ANNEXURE 'A'

# Neelkanth Mahadev Welfare Society E VOTING PROCEDURE & FAQs

# Q.1- How can I vote?

Just visit on the given link <a href="http://election.neelkanthmahadevsociety.com/">http://election.neelkanthmahadevsociety.com/</a> and follow the steps mentioned below.

- a). You have to fill any 2 fields
  - Membership No.
  - · Registered email.
  - · Registered mobile number.
- b). After filling any two fields, you will receive an OTP on your registered mobile number and email id. You can use the OTP and login on the election portal.
- c). You will be able to see the list of various posts on your screen. Select the post and you will see the list of contesting candidates for respective post. Click on the "Vote Now" button and confirm. You will receive the confirmation message on your registered mobile number. After the confirmation you will not be able to change your choice.
- d). A voter can cast total 13 votes, out of which 7 for the post of "Office Bearers" and 6 for the post of "Members" of the management committee.

Q.2 what if I do not remember my membership number?

You can login using your registered mobile number and email id.

Q.3 What if I do not get the OTP on my mobile?

You can check the OTP on your registered mobile number as well as your registered email id.

Q.4 How can I check that I have casted my vote successfully? You will get a confirmation message on your registered mobile.

Q.5 What will happen after voting for all the posts?

You can use an option "Elected Summary" given in member voting dashboard. You can see list of votes casted. You have an option for downloading the list of vote casted.

Q.6 How long the OTP is valid?

OTP is valid maximum 30 min. for each login
